In this seminar we will examine the reasons for dissents, the impact that powerful dissents have on constitutional jurisprudence, and also different types of dissents. The theme is that certain dissents form an integral part of the constitutional dialogue.

It is suggested—but not required—that students purchase Melvin Urofsky, *Dissent and the Supreme Court* (Pantheon, 2015). I will not be "teaching the book," but it will help give you a better understanding of the context of the cases we examine.

Since this is a seminar, we will be discussing cases, and therefore participants should read the assigned cases before the class. If you are reading the cases on-line, you may bring a laptop or tablet to class. The cases are available on the GW portal and on the Google page.
