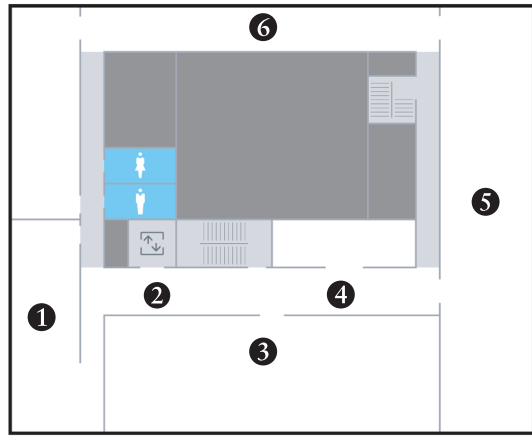


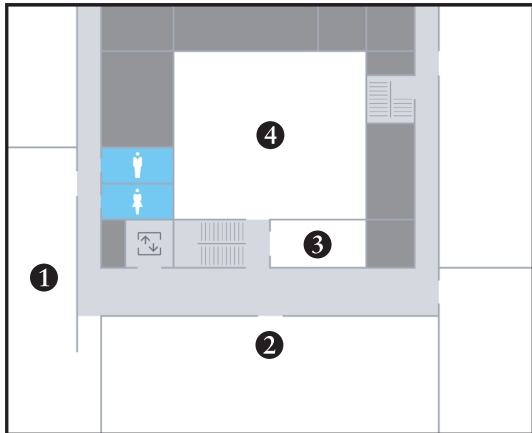

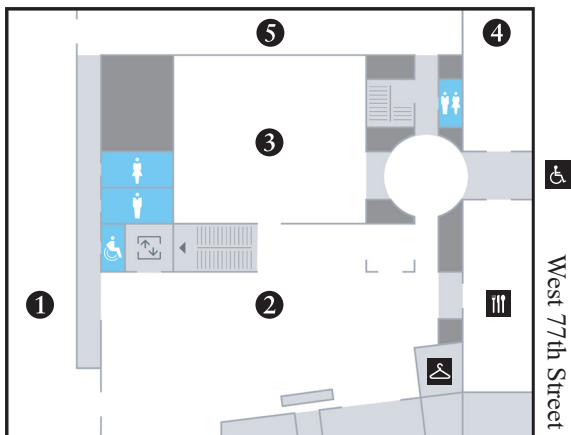

Safety Protocols

Health Screening

We kindly ask that you refrain from visiting if within the past 14 days you have experienced COVID-19 symptoms, have tested positive, or have knowingly been in contact with someone who has tested positive or has experienced COVID-19 symptoms.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. People visiting the New-York Historical Society do so at their own risk.

Hygiene

Hand sanitizers are available throughout the building. Maintenance staff performs enhanced cleaning throughout the day.

Services for visitors who are deaf or hard of hearing

- Most exhibition audio is accessible to t-coil hearing aid users.
- Assistive listening devices and neckloops are available in the auditorium.
- All exhibition films and videos are open captioned. Transcripts of *New York Story* are available. Please ask a staff member for assistance.

Services for visitors who are blind or have low vision

- Text for major exhibitions is available in Large Print. Please inquire at Admissions.

Services for visitors with mobility impairments

- The building, galleries, and auditorium are wheelchair accessible, and a wheelchair accessible entrance is located at 2 West 77th Street. Wheelchairs are available to visitors free of charge. We recommend reserving in advance by calling (212) 485-9200.

Face Masks & Social Distancing

Face masks are required for all staff and visitors over the age of 2. If you need one, we will provide it free of charge. Proper social distancing of at least six feet is required.

Touch-Screen & Audio Interactives

A free, disposable stylus is available at Admissions so visitors can safely interact with touchscreens. Disposable headphones are also available.

Gallery Policies

- Photography**
Visitors are welcome to take photos of most exhibitions and objects, except where noted. The use of flash, tripods, and selfie-sticks is not permitted.
- Bag and coat check**
For safety reasons, our bag and coat check are temporarily closed.
- Strollers**
All of our galleries are stroller-friendly.
- Baby-changing facilities**
Baby-changing facilities are located in the family restroom on Level One.
- Mobile devices**
While we encourage the use of mobile devices to access information about collections and exhibitions, please do not place phone calls in the galleries.
